

Hamilton Parks Got Talent

Terms and Conditions

These terms and conditions ("Terms") govern the participation in Hamilton Park's Got Talent ("Competition"), organized by Hamilton Park ("Organiser"). By submitting an audition video, you ("Applicant") agree to be bound by these Terms.

1. Eligibility

- 1.1 Applicants must be aged 12 years or older on the closing date for entries (Wednesday 11th September 2024).
- 1.2 The competition is open to amateur performers of all talents including but not limited to singers, dancers, musicians and magicians.
- 1.3 The Organiser reserves the right to exclude any entries deemed inappropriate, please note auditions/acts must be appropriate for a family audience.
- 1.4 All entries by persons under the age of 16 require written consent to enter the competition by their parent or guardian and must be accompanied by an adult should they make the final.
- 1.5 By entering the competition it is assumed you are not tied to any record label or agency that would prohibit you from doing so.

2. Application Process

- 2.1 Applications will be accepted via email only, sent to abbie@hamilton-park.co.uk.
- 2.2 The application period opens on Sunday 1st September and closes at midnight on Wednesday 11th September 2024.
- 2.3 There are no specific video format requirements, but the Organiser encourages videos to be clear and concise.
- 2.4 Entries submitted outside office hours will be responded to at the earliest opportunity.
- 2.5 By submitting your audition video, you are entering into the competition and therefore giving Hamilton Park the right to publicise your entry as they see fit including but not limited to use of your audition on social media.

3. Selection Process

- 3.1 A panel of judges will select a maximum of 10 finalists from the received audition videos.
- 3.2 The finalists will be announced on Hamilton Park's social media channels on Friday, 13th September 2024.

4. Final Event

4.1 The final competition will be held at the USave Utility Contracts Raceday on Sunday, 22nd September 2024.

5. Prizes

- 5.1 The winner of the competition will receive a cash prize of £1,000.
- 5.2 The winner will also have the chance to feature on Go Radio's "Fresh Artist Fridays" with Crofty and Grado at Breakfast.
- 5.3 All remaining finalists will receive two tickets to any 2025 Hamilton Park fixture of their choice.

6. Judging

- 6.1 The judges' decision is final and cannot be challenged.
- 6.2 The judging criteria will be based on talent, performance, and audience engagement.
- 6.3 The winner will be determined at the discretion of Hamilton Park and the judges of the competition and their decision is final.
